## Usage Information

1. Strip floors to remove buildup of old finishes, sealers or waxes.
2. Thoroughly rinse with cold water and let floor dry.
3. Apply thin to medium even coats of SE80 with an appropriate finish mop or applicator.
4. Allow each coat to dry before applying next coat—30 mins. drying time recommended under normal conditions.
5. Apply a maximum of 4-6 coats in a 24-hour period.
